Invitation to comment on RSPO Annual Surveillance Assessment – ASA 4 of PT Inti Indosawit Subur (RSPO Membership No: 1-0022-06-000-00), Plantation Management Unit – PT Rigunas Agri Utama, Sengkilo Village, Peranap District, Indragiri Hulu Regency, Riau, Indonesia

PT Inti Indosawit Subur has commissioned Intertek Certification International Sdn Bhd for the assessment and certification of its Plantation Management Unit, PT Rigunas Agri Utama against the requirement of the Roundtable on Sustainable Oil Palm, Principles and Criteria (RSPO P&C, 2013) and in line with the Indonesian - National Interpretation Task Force (RSPO INA – NITF, July 2016) and RSPO SCCS, June 2017 for Palm Oil Mill.
