Type Test Certification also provides excellent documentary evidence to support a manufacturer's Declaration of Conformity with the essential requirements of the applicable directives. Test Certificates are issued when samples of a particular product design have been tested satisfactorily against the requirements of a National, European or International standard

Several forms of these Certificates are available as follows

**Certificate of Type/Verification Tests:** Verifies complete series of type/verification tests prescribed in a Standard has been made successfully.

**Certificate of Selected Type/Verification Tests:** Verifies specified type/verification tests have been made successfully

**Certificate of Short-Circuit Rating:** Verifies the short-circuit performance of the design. The Certificate may include the results of other type tests, e.g. mechanical endurance tests.

**Supplementary Certificate:** Extends the scope of an existing Certificate to cover changes in rating or in design

**ASTA Test Report:** An ASTA Test Report is issued when tests otherwise satisfactory cannot be included in a Certificate for one or more reasons, e.g. verification of non-standard ratings
