

# BES 6001 CERTIFICATION

BES 6001 is an independent, third-party certification scheme designed to enable manufactured products to be assessed and certified as being responsibly sourced. Responsible Sourcing of Construction Products is demonstrated through an ethos of supply chain management and product stewardship and encompasses social, economic and environmental dimensions.

### Background

BES 6001 is recognized by the BREEAM family of certification schemes and the Code for Sustainable Homes where credits can be awarded for construction products independently certified through the BES 6001 Framework Standard.

BES 6001 is relevant to any organization that manufactures construction products from foundation products such as cement and steel to concrete pipes, blocks, windows, flooring, roof tiles, plastics, and wood products.

Consumers are increasingly concerned about where the products they are buying come from. Highly visible responsible sourcing schemes are now established and recognised world-side, such as Fairtrade, Rainforest Alliance, Marine Stewardship Council, FSC, PEFC etc.

### BES 6001- The Framework Standard for Responsible Sourcing

The standard describes a framework for the organisational governance, supply chain management, and environmental and social aspects that must be addressed in order to ensure the responsible sourcing of construction products.

Independent, third party assessment and certification against the requirements of BES 6001 give an organisation the ability to prove implementation of an effective system for responsible sourcing and the added credibility to product claims made.
