Background

The Bureau of Indian Standards (BIS) is the national standards body of India (established under the BIS Act, 2016) which promotes the development of standardization and quality certification of goods. The BIS Product Certification Scheme under the BIS Act, 2016, provides a third-party guarantee of quality, safety, and reliability of products to end-consumers located in India.

How Are Chemicals Manufacturers Impacted?

The BIS certification is voluntary in India; however, the government of India has made the BIS certification mandatory for certain products placed on the Indian market (manufactured / imported). This is enforced to protect human health and safety, protect the environment, prevent deceptive production practices, build consumer security, and more.

How Are Certifications Granted?

Under the BIS Act 2016, BIS Rules 2018, and BIS (Conformity Assessment) Regulations 2018, there is a provision for Grant of Licence (GoL). The BIS grants a licence to both domestic and foreign manufacturers of chemicals based on a successful assessment of manufacturers'

infrastructure, production processes, quality controls, and testing capabilities through a visit to the manufacturing premises. The BIS also assesses the product's conformity to relevant Indian Standards (IS) through third-party laboratory testing or testing in the manufacturing premises, or a combination of both.

All products that are certified under the BIS Product Certification Scheme(s) can use the BIS Standard Mark.
