# TRADING WITH CAMEROON

in Cameroon

**Exporters/Importers trading with Cameroon need to comply with the requirements of Cameroon's Government office, Agence des Normes et de la Qualité (ANOR) Conformity Assessment Programme called Programme d'Évaluation de la Conformité Avant Embarquement (PECAE) in order for their goods to clear customs. Failure to do so can result in severe delays in goods clearance, penalties, or even shipments being returned.**

The programme in Cameroon has been implemented to assure Cameroon's consumers of the quality and safety of imported goods. ANOR requires that all imports of regulated products comply with mandatory safety and related standards. Every consignment of imported goods must comply with the PECAE.

#### The requirements for Cameroon are:

- Every consignment of imported goods requires a proof of product verification by way of an Attestation of Conformity (AoC). Intertek is authorised to issue the AoC.
- Upon receipt of the AoC, ANOR will issue the Certificate of Conformity (CoC) required for customs clearance of shipments.
- The Certificate confirms that the products comply with the relevant Cameroon technical regulations, national, regional or international standards.
- The authorities in Cameroon may take random samples from imported consignments to verify compliance.


