all products/services/sites/locations of the organization are covered by the scope of certification.

- 1.5. The mark(s) cannot be altered or modified. However, it may be resized, provided the proportions of the entire mark are maintained and all features of the mark are clearly distinguishable.
- 1.6. When displayed in conjunction with the accreditation mark(s), Intertek's mark(s) may only be reproduced in black. When displayed without the accreditation mark(s), Intertek's mark(s) may be reproduced in black or in the predominant color of the letterhead or printing. The mark may only
- 1.7. be reproduced on a clearly contrasting background.
- **1.8.** Whenever the Intertek certification mark is used by a certified client, the certificate number shall be used in adjacent to the Intertek SA8000 Certification Mark in order to identify the factory certified.
- 1.9. The client shall not use the certificate and/or the certification mark(s) provided by Intertek in such a manner that would bring Intertek, and/or the accreditation body, and/or the certification system into disrepute and lose public trust.
- 1.10. Under no condition shall the mark be affixed to a product or used in any way that might suggest product certification. The mark applies only to the social accountability management system certification.

- 1.12. The right to use the certification mark by the organization cannot be assigned to or acquired by any other person, entity, or corporation (including through a change of ownership of the organization) without Intertek's prior written consent.
- 1.13. Upon a reduction of the scope of certification, the client shall amend all advertising material referring to its certification to properly reflect the reduced scope.
- 1.14. Upon suspension or withdrawal of its certification, the client shall discontinue its use of all advertising material that contains a reference to the SA8000 certification, as directed by Intertek.

2. Use of accreditation body (SAAS) mark

Use of the accreditation body mark is permitted in accordance with the rules specified above, and the extra requirements identified in the following sections:

- 2.1 An Intertek SA8000 certified facility may use the SAAS accreditation mark for SA8000 only in conjunction with Intertek certification mark on the facility's stationery, literature, and website subject to the conditions below.
- 2.2 The SAAS accreditation mark for SA8000 shall be reproduced:
 - in the specified colors below or in the predominant color of the letterhead or printing, per the SAAS accreditation mark color requirements;
 - on a clearly contrasting background;
 - the mark may be reversed (i.e., negative of the above example) provided the background on which it is displayed, is dark enough to clearly identify and display the entire mark;
 - in a size which makes all features of the mark clearly distinguishable.
- 2.3 When using the SAAS accreditation mark for SA8000 by the certified organization, its size must not differ from the size of Intertek Certification mark.
- 2.4 Neither the Intertek Certification mark nor the SAAS accreditation mark for SA8000 shall be used on a product by a certified organization, its labeling or packaging, or in such a way as to suggest that Intertek or SAAS have certified or approved any product, process or service of a certified facility, or in any other misleading manner.
