This is to inform that the above Management Unit under the Parent Company IOI Corporation Berhad with RSPO membership number 2-0002-04-000-00 had appointed Intertek Certification International Sdn Bhd to conduct the Initial Certification/Recertification Audit/Surveillance Audit (RA-01) at Pamol POM and its supply base, located at Sandakan, Sabah. The audit will be conducted from 09 - 13 August 2021 against the requirements of:
