WHAT IS MRSL CONFORMANCE?

The levels of conformance are related to the confidence that any specific batch of the chemical formulation will meet the MRSL requirements. Higher levels of conformance mean that there is increasingly more known about the chemical formulation and the environmental health and safety practices of the chemical supplier.

Depending on the conformance level it may be:

- Level 0 (self-declaration)
- Level 1 (test report or third-party documentation review),
- Level 2 (includes a review of the formulation and documentation review of the chemical supplier's product stewardship)
- Level 3 (review which requires a supplier site visit as a part of the product stewardship review)



MRSL V1.1 VERSUS V2.0

1. Additional Chemicals

Many problematic chemical substances have been added to the list of restricted substances, including restrictions for new substrates: rubber, foams and adhesives. Efforts have been made to align with the industry and cover more 'hazardous' substances.

There are 8 substance groups of chemical adding to Smart Testing Grid

- Anti- Microbials & Biocides
- Chlorinated Paraffins
- Borate, Zinc salt
- Bisphenol A
- Thiourea
- Quinoline
- AEEA [2-(2-aminoethylamino)ethanol]
- UV Absorbers

2. New Chapters

Two new chapters have been added to version 2.0. This increases the scope of the ZDHC MRSL, while helping the industry to prepare for future restricted chemicals.

- 1. ZDHC MRSL Candidate List (will be added in v3.0)
- 2. Archived substances (previously been used in the industry, and are no longer in use)

3. ZDHC MRSL Level 0 conformance declarations

Last date for adding a Level 0 is December 31, 2019. This also means that as from January 1, 2021 there will not be any level 0 certification on the Gateway.

4. Update on smart testing grid

Smart Testing Grid updated as 1. Textile, 2. Leather, 3. Synthetic Leather, and 4. Polymers (Rubber, Foam and Adhesives)

CHEMICAL APPROVAL PROCESS

Starting 2nd March 2020, all certification organizations should approve formulators' products certified by them in ZDHC Gateway directly.

Direct verification by certification bodies

What happens before and after verification..



- If Verify → ZDHC MRSL Conformant
- If Not Verify → Registered

..and some verification acceptance rules for certification bodies:

- 01.01.2020 01.01.2021 → Verify both ZDHC MRSL V1.1 and V2.0
- 01.01.2021 onwards → Verify ZDHC MRSL V2.0 only






TIMELINE SWITCHING FROM V1.1 TO 2.0

As with the introduction of any updated guideline, a transition period has been provided to put the latest version into action. The chemical industry will have a transition period of **12 months** to implement ZDHC MRSL V2.0.

We've identified four key stakeholder types that play a key role: Certification Bodies, "Chemical" Formulators, Facilities/Suppliers and Brands/Retailers. By implementing in a collaborative, connected way, these stakeholders can reduce the impact of the implementation efforts. This document provides a standard approach to help achieve this.
