# TRADING WITH IVORY COAST

Intertek's Total Quality Expertise supporting Exporters and Importers to comply with the Verification of Conformity (VoC) Programme in Ivory Coast

## TRADING WITH

Exporters/Importers trading with Ivory Coast need to comply with the requirements of the Ministère du Commerce de l'Artisanat et de la Promotion des PME (MCAPPME) in order for their goods to clear Ivory Coast Customs.

It is mandatory to obtain a Certificate of Conformity (CoC) for Regulated Product shipments prior to exporting into Ivory Coast.

The programme will commence on 16th July 2018. All regulated product shipments scheduled to arrive at Ivory Coast Ports and Borders with a Bill of Lading (B/L) or AWB dated on or after 16th July 2018 should be accompanied with the CoC. The CoC must be presented by the Importer to the Ivory Coast Customs for clearance of their goods. Regulated product shipments arriving at Ivory Coast Ports and Borders without a CoC will be liable for a penalty fee.

The Verification of Conformity (VoC) programme provides assurance to Ivory Coast consumers of the quality and safety of imported goods.

### The requirements for Ivory Coast are:

- Every consignment of imported goods requires a proof of product verification by way of a Certificate of Conformity (CoC). Intertek is authorised to issue the CoC.
- The Certificate of Conformity (CoC) is required for Customs clearance of regulated product shipments.
- The Certificate confirms that the products comply with the relevant Ivorian Technical Regulation, National, Regional or International Standards.
