Invitation to comment on MSPO Stage 2 of Felda Global Ventures Holdings Berhad, Plantation Management Unit – Kompleks Adela grouping, Kota Tinggi, Johor, Malaysia

Felda Global Ventures Holdings Berhad has commissioned Intertek Certification International Sdn Bhd for the assessment and certification of its Plantation Management Unit, Kompleks Adela grouping against the requirement of the Malaysian Sustainable Palm Oil Standards series, MSPO 2530-3 (2013) General principles for oil palm plantations and organised smallholders and MSPO 2530-4 (2013) General principles for palm oil mills.
