**Invitation to comment on MSPO Annual Surveillance Assessment (ASA-01) of FGV Holdings Berhad,  
Plantation Management Unit – Kompleks Bukit Kepayang grouping, Pahang, Malaysia**

FGV Holdings Berhad has commissioned Intertek Certification International Sdn Bhd for the assessment and certification of its Plantation Management Unit, Kompleks Bukit Kepayang grouping against the requirement of the Malaysian Sustainable Palm Oil Standards series, MSPO 2530-3 (2013) General principles for oil palm plantations and organised smallholders and MSPO 2530-4 (2013) General principles for palm oil mills.
