**Invitation to comment on RSPO Annual Surveillance Assessment (ASA-01) of IOI Corporation Berhad (RSPO Membership No: 2-0002-04-000-00), Certification Unit – Syarimo grouping, Kinabatangan, Sabah, Malaysia**
