Invitation to comment on RSPO Annual Surveillance Assessment (ASA-02) of IOI Corporation Berhad (RSPO Membership No: 2-0002-04-000-00), Certification Unit - Syarimo grouping, Kinabatangan, Sabah, Malaysia
