Invitation to comment on RSPO Annual Surveillance Assessment (ASA-03) of IOI Corporation Berhad, Plantation Management Unit – Pukin grouping, Rompin (Pahang) and Segamat (Johor), Malaysia

Currently, a significant number of its Plantation Management Unit (PMU) is undergoing the RSPO certifying process in accordance with its time bound plan to achieve RSPO certification for its entire PMU's at the end of year 2016.
