Invitation to comment on RSPO Annual Surveillance Assessment (ASA-01) of Mong Reththy Investment Cambodia Oil Palm Co. Ltd, Plantation Management Unit – MRICOP Grouping, Choeng Kor Commune, Prey Nop District, Sihanoukville, Cambodia

Mong Reththy Investment Cambodia Oil Palm Co. 
