Invitation to comment on RSPO Annual Surveillance Assessment (ASA-01) of IOI Corporation Berhad, Plantation Management Unit – Pukin Grouping, Rompin (Pahang) & Segamat (Johor), Malaysia

IOI Corporation Berhad has commissioned Moody International Certification (Malaysia) Sdn Bhd for the assessment and certification of its Plantation Management Unit, Pukin Grouping against the requirement of the Roundtable on Sustainable Oil Palm, Principles and Criteria (RSPO P&C) and in line with the Malaysian National Interpretation (MYNI) and RSPO SCCS (2011) for Palm Oil Mill.

The certification unit are located at Rompin (Pahang) & Segamat (Johor).

In brief, IOI Corporation Berhad has been a member of RSPO since 18th May 2004 and is committed to full compliance with the RSPO P&C and full certification in all aspects of its operations. IOI Corporation Berhad owns and operates 12 palm oil mills and 77 estates (as per update on June 2012), throughout Malaysia and Indonesia. Currently, a significant number of its Plantation Management Unit (PMU) is undergoing the RSPO certifying process in accordance with its time bound plan to achieve RSPO certification for its entire PMU's at the end of year 2016.
