Invitation to comment on RSPO Certification Assessment of IOI Corporation Berhad, Certification Unit – Mayvin Grouping, Sandakan, Sabah, Malaysia

IOI Corporation Berhad (IOI) has applied to Moody International Certification (Malaysia) Sdn Bhd for assessment of the Mayvin Grouping located at Sandakan, Sabah against the requirement of the Roundtable on Sustainable Oil Palm, Principles and Criteria (RSPO P&C) and in line with the Malaysian National Interpretation (MYNI).

IOI owns a total of 97809 hectares of plantations in Sabah, 50904 ha in Peninsular Malaysia and 64500 ha in Indonesia.

IOI operates 12 palm oil mills and 77 oil palm estates throughout Malaysia and Indonesia. The organization is a pioneering member of RSPO and has been taking an active role in the RSPO certification processes since 2004. Currently, a significant number of its Plantation Management Units (PMU) is undergoing the RSPO certifying process in accordance with its time bound plan to achieve RSPO certification for all its PMUs by **June 2011**.

Moody International Certification has planned to conduct the proposed certification assessment which will **commence on 24th August 2010**.


