Invitation to comment on RSPO Certification Assessment of IOI Corporation Berhad, Certification Unit – Pukin Palm Oil Mill, Rompin, Pahang, Malaysia

IOI Corporation Berhad (IOI) has applied to Moody International Certification (Malaysia) Sdn Bhd for assessment of the Pukin Palm Oil Mill located at Rompin, Pahang against the requirement of the Roundtable on Sustainable Palm Oil, Principles and Criteria (RSPO P&C) and in line with the Malaysian National Interpretation (MYNI).

IOI owns a total of 50904 hectares of plantations in Peninsular Malaysia, 97809 ha in Sabah and 64500 ha in Indonesia.

IOI operates 12 palm oil mills and 77 oil palm estates throughout Malaysia and Indonesia. The organization is a pioneering member of RSPO and has been taking an active role in the RSPO certification processes since 2004. As of September 2010, 4 Plantation Management Units (PMU) has been certified RSPO and a significant number of PMU is undergoing the certifying process in accordance with its time bound plan to achieve all by **December 2011**.

Moody International Certification has planned to conduct the proposed certification assessment which will commence on **8th December 2010**.


