Invitation to comment on RSPO Annual Surveillance Assessment (ASA-02) of IOI Corporation Berhad, Certification Unit – Mayvin Grouping, Sandakan, Sabah, Malaysia

In brief, IOI Corporation Berhad has been a member of RSPO since 18th May 2004 and is committed to full compliance with the RSPO P&C and full certification in all aspects of its operations. IOI Corporation Berhad owns and operates 12 palm oil mills and 80 estates (as per update on 2011), throughout Malaysia and Indonesia. Currently, a significant number of its Plantation Management Unit (PMU) is undergoing the RSPO certifying process in accordance with its time bound plan to achieve RSPO certification for its entire PMU's at the end of year 2015.
