

# SOUTH KOREA OSHA/ISHA AMENDMENT OBLIGATIONS

# Comprehensive Regulatory Support

#### **Background**

On January 15, 2019, South Korea published the amended Occupational, Safety and Health Act (OSHA) also known as the Industrial, Safety and Health Act (ISHA). The amended Act entered into force on January 16, 2020.

Notably, the amendments related to hazard communication, including Safety Data Sheet (SDS) requirements will come into force on January 16, 2021.

As a result, submission of a Korean SDS to the Ministry of Environment and Labour (MoEL), before manufacture or import will be required, for a chemical substance or mixture, which is classified as hazardous under Korean GHS.

### There are three options:

- Option 1: disclose 100% composition information in the SDS (including nonhazardous components), and submit the SDS to MoEL through the SDS IT System.
- Option 2: only disclose hazardous components in the SDS and submit the SDS along with a separate document providing the name and content of nonhazardous components to MoEL.
- Option 3 (for imported products only):
  only disclose hazardous components
  in the SDS and submit the SDS along
  with a statement signed by the foreign
  company stating that all the non disclosed components are non-hazardous
  substances.

#### **Korea Only Representative Services**

Through our legal entity in South Korea, Intertek can deliver a comprehensive Korean Only Representative (OR) Service according to ISHA, Enforcement Rule, Article 166. It should be noted that an Only Representative appointed under ISHA is a distinct OR compared to one appointed under K-REACH.

By appointing an ISHA Only Representative, a foreign manufacturer can protect Confidential Business Information (CBI). Our ISHA OR service builds on our experience of Only Representation under K-REACH, European Union REACH Regulation OR services, and Notifying Agent services under China's Order No. 7.

#### **CBI Protection**

If your company does not want to disclose CBI such as the chemical name and content of a hazardous component in their Korean SDS(s), an application to the MoEL needs to be made. The application must be approved by the MoEL and lasts for five years after which another application for extension of CBI protection must be made.
